On behalf of the Bonagany committee, I'm writing to invite you to apply for Bonagany 2017! This year will be our thirteenth year of celebrating the friendship between the community of Allegany and St. Bonaventure University! Bonagany is a great opportunity for regional artists, food vendors, retail vendors to share their goods with a bigger audience, made up of residents as well as Bonaventure parents and alumni. We expect over 3,000 festival-goers and more each year. And it's very low cost to participate! Here's what you need to know:

Date Saturday, September 23, 2017 from 11am until 5pm;
Allegany Main Street

Setup Main Street will be closed for vendor setup; vendors may have vehicles on the street between 8am and 10am *only*; please find your assigned spot, unload, and move your vehicle to the vendor parking area immediately; your assigned spot will be emailed to you the week of the event; you must be completely set up by 10:30am; there will be no rain location, so all vendors (with the exception of student clubs/organizations) will be required to bring a 10x10 tent; there will be no power available to non-food vendors; vendors are asked to stay set up until 5pm, break down their displays, and only then retrieve vehicles for loading. All vehicles must be off the street by 6pm.

Eligibility Food, fine art, interactive art (face painting, workshops, etc.), homemade crafts, retail, nonprofit organizations, entertainment, amusements, student clubs, student organizations; prevention of duplicate foods will be determined on a first-come-first-serve basis; all vendors planning on selling goods must have a NYS sales tax license on display.

Fee \$50 for food vendors; \$30 for all others; free for non-profit groups; make checks payable to "Bonagany"
Deadline September 15, 2017; add \$10 late fee after this date; due to insurance paperwork, no applications will be accepted after September 20th.

With your approved application and payment, we'll email you the week of the event with an event map, parking information, your assigned spot and other details for the day. Please excuse our unique application—it's for insurance purposes for the Village of Allegany! And if you need to print another application, they're now available at **www.bonagany.org**. We hope to hear from you soon.
