Mayor G. Pearl would like the minutes to reflect that the DPW staff has embraced the no idle time of village vehicles. There has been a significant savings in that department. Police idle time is a work in progress.

Danielle McMullen from Energy Next Inc. addressed the Village Board and others present. She spoke about the possible savings for residents of participating municipalities. The concept is the more households that could be included to bid out the supply portion of their electric bill would have a larger savings. She stated that the Village and Town would have to participate together or it would not be an option. The steps to participate are as follows:

Choose Mega, Educate Public, Adopt Law, Compile Bid, Select Bidder, Citizens opt out and then Savings begin

Question: Town Supervisor John Hare: What the difference is between CCA and other supplies that offer similar benefits?

Answer: Danielle McMullen: The only difference is that they are on a larger scale and with more participants the cost would be lower.

Question: Trustee M. Meyers: How often is it renewable?

Answer: Danielle McMullen: That would be up to the Village/Town. Usually 18 – 36 months.

Question: Trustee M. Meyers: What are the average savings?

Answer: Danielle McMullen: There is no way of knowing until bids are taken in.

Question: Town Trustee James Hitchcock: Is this strictly residential?

Danielle McMullen: This is offered to municipalities, schools and businesses as well.
