#### **POLICE**

- Rouleau asked why the burglary at Don Lucho's was not in the newspaper. Papasergi is requested to speak with the board members about it.
- Fodor said the police log can be put on the website.
- Rouleau asked about the drug bust in the village.
- Rouleau inquired about what happens to old police equipment when new is ordered.
- Rouleau wonders when a police meeting will be scheduled. Evaluations need to be done.
- Lockers that the police department wanted have not been used at all.

#### DPW

- Rouleau asked where we stand with GPS.
- Rouleau asked about the website, feels it is not updated. Flynn is working on the Local Laws and can put some on the website now. Rouleau asked if someone can enter the information. Flynn said a municipal website has to have the proper authorized personnel enter the information, not just anyone.
- Where do we stand on the truck bid? Flynn informed the board that Papasergi is trying to get the specs ready for it.
- Rouleau asked about a hole in the middle of the railroad tracks on S. 7<sup>th</sup>.
- Rouleau asked about someone going through the village with trash in the back of their vehicle and it going all over. Flynn didn't think there was a local law requiring the covering of trash. Will ask Jobe.
- Lamberson questioned the hydrant on Pierce Dr. Peterson said it would turn on but not sure if it can be turned off, check with Papasergi to see if it needs to be replaced.
- Lamberson wondered what streets will be worked on this summer.
- Gleason and Rouleau would like to review the DPW summer applications.
- Papasergi to provide Fodor a list of municipalities for the County Shared Service Agreement.
- Board is recommending that a shared service agreement be completed for ALCS and Allegany Fire Department. Fodor to draft an agreement.
- Fodor wants Jobe to contact her regarding his decision on the trailer on Nolan Drive, complaint by Kirkpatrick's. Are there state regulations independent of the village Property Maintenance Code that would override the village law?

### **OTHER**

- Fodor wants to attend a hydrofracking seminar in Albany. Village issues include risk to the aquifer and truck limitations on village roads.
- Lamberson suggested that Fodor also attend classes for arbitration and negotiation tips.
- Jobe to contact Fodor about Planning and Zoning Board mandatory training.
- Fodor advises Parker of the Library's need to form a corporation or a 501c3 non-profit organization.
