POLICE

<u>Gary McCready</u>, residing at 133 West Main St. attended to follow up on his complaint of 1/4/10.

- His neighbor has still been driving up the sidewalk and subway, racing in and out.
- Gary states he has been verbally abused and has also verbally abused the neighbor.
- Neighbor spins out in the driveway for 2-3 minutes straight.
- Chief stated that to get into the driveway, he can go in at an angle.
- Police cannot legally do anything, it's just like someone turning around in your driveway, and it is not illegal.
- Unless the police visualize something happening, they can't charge anyone. They have seen no evidence of wrong-doing thus far.
- Police have been at that address and see no tire tracks or evidence.
- Sidewalk is state property.
- Call police department immediately when he observes something happening.
- Chief will speak with surrounding neighbors to find out what they've observed and possibly get statement(s).
- Board of Trustees cannot solve the problem, it is up to the police.
- Board suggested that he call NYSDOT.

St. Bonaventure University students have returned from semester break.

- Chief has cut back on the number of officers on the weekend from 6 to 5.
- Officer Conner is doing traffic, grant money pays for this.
- When students start in the fall, Chief puts more patrolmen out.
- There is a new Director of Security at SBU.
- Trustee Rouleau asked if any jay-walking tickets are issued, Chief is unaware of any.
- ➤ Trustee Rouleau wondered what coverage we have when Officer Bartucca takes his K-9 to local school districts to do drug searches. Chief stated it would be covered under Mutual Aid. Clerk to check with our insurance company.
- Police officers to make a list of light outages.
- ➤ Letters of thanks to Officer Bartucca from school districts for his K-9 services were put on file.

DPW

- Snow piles are being hauled away.
- Sidewalk plow is now running well.
- Supt. Papasergi will check the snow on sidewalks.
- Street light in front of the library is cycling on/off.
- Mayor Lamberson, Trustee Fortuna, Rena & Dominic will meet with Mayor Witte and other public officials to discuss the annual sewer bill. Attorney Fodor will also be asked to attend.

- Hope to eventually hook up building camera monitors with sound.
