Motion by Hare WHEREAS, the Town Board of the Town of Allegany (herein the "Town Board") has previously adopted Ordinance #1 of 2011, creating a Wind Energy Overlay District in the Town of Allegany, upon the application from Allegany Wind LLC for said rezoning; and WHEREAS, Allegany Wind has abandoned its wind energy project in the Town of Allegany, and terminated efforts to obtain a new Special Use Permit for its project; and WHEREAS, pursuant to the Town of Allegany Zoning Ordinance II and Town Law Section 130, the Town Board held a public hearing to consider adoption of a new ordinance (the "Rescission Ordinance") rescinding Ordinance #1 of 2011 and removing the Wind Energy Overlay District from the Town zoning map; and **WHEREAS**, the Town Board referred the Rescission Ordinance to the Cattaraugus County Planning Board pursuant to General Municipal Law Section 239-m, and the County Planning Board recommended approval of the Rescission Ordinance; and WHEREAS, the Town Board referred the Rescission Ordinance to the Town Planning Board, pursuant to Zoning Ordinance II, and the Town Planning Board recommended approval of the Rescission Ordinance; and WHEREAS, the Town Board, pursuant to Article 8 of the Environmental Conservation Law, Chapter 43B of the Consolidated Laws of New York, as amended ("SEQR Act"), and the regulations (the "Regulations") adopted pursuant thereto by the Department of Environmental Conservation of the State

of New York (collectively with the SEQR Act, "SEQRA"), reviewed the EAF for the Rescission Ordinance, took a hard look at the environmental impacts of the Rescission Ordinance and issued a Negative Declaration of Environmental Significance. **NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF TOWN BOARD OF THE TOWN OF ALLEGANY AS FOLLOWS**: 1. Ordinance #1 of 2011, creating the Wind Energy Overlay District in the Town of Allegany is hereby rescinded by the Ordinance #1 of 2014, which is incorporated herein. 2.
