The cost of stamped asphalt was over \$167,000. Trustee D. Papasergi doesn't want the brick removed. He stated that he had talked to the merchants in town and most didn't want the brick removed. Trustee D. Papasergi also stated that the Village attorney should reach out to New York State to make sure it is our responsibility to fix. Mayor G. Pearl stated that attorneys were involved back in 2011 and at that time they informed the Village that is was the Village's responsibility. As well as calls that were made to New York State confirming it by DPW Superintendent F. Snyder and Clerk Treasurer K. Roth. Trustee R. Barton stated that something needed to be done to fix the issue. Much discussion was done. The cost of replacing the brick with concrete or asphalt is too much and not budgeted for. At this time the board requested the DPW remove and replace a portion of brick to see if that will remedy the situation. DPW Superintendent F. Snyder stated that he would have someone work on it and report back to the board at the July meeting.
