ORDINANCE AUTHORIZING AND ESTABLISHING A BAN ON PUBLIC PARKING ON TOWN HIGHWAYS , TOWN OF ALLEGANY, NEW YORK, TO AID IN SNOW REMOVAL BETWEEN NOVEMBER 1ST AND APRIL 1ST IN EACH YEAR HEREAFTER

The Town Board of the Town of Allegany, hereby ordains and enacts as follows:

SECTION 1: During the period of November 1st through April 1st in each year hereafter, parking on town highways designated by the New York State Department of Transportation, as setforth on the list of highways hereto annexed, is strictly prohibited.

SECTION 2: The Town Superintendent of Highways is hereby authorized to cause the removal of any vehicle parked on a Town Highway in violation of this Ordinance, and shall impound said vehicle until the cost of removing said vehicle has been paid to the Town Clerk.

SECTION 3: The Town Clerk shall establish fees for removal and storage of vehicles to be published upon the Town Bulletin Board, and which will reflect as near as possible the cost to the Town for removal of vehicles provided for hereunder.

SECTION 4: The Town Superintendent of Highways may in his discretion post such notices and/or signs as he deems appropriate on roads entering the Town of Allegany advising of the parking ban for snow removal purposes, but failure to post signs shall not in any way impair the effectiveness of this Ordinance or prevent the Town from the full enforcement thereof.

SECTION 5: This Ordinance shall take effect immediately.
